RESOLUTION GRANTING PROPERTY TAX EXEMPTION PURSUANT TO NDCC 57-02-08(35)

WHEREAS, the Pembina County Commission, acting by and through its duly elected representatives, desires to encourage the construction of new residential dwellings in Pembina County, North Dakota; and

WHEREAS, North Dakota statutory law authorizes the Pembina County Commission to grant exemptions up to \$150,000.00 of the true and full value of residential dwellings for single family homes, condominiums and townhomes;

NOW, THEREFORE, BE IT RESOLVED by the Pembina County Commission that, pursuant to section 57-02-08(35), up to \$150,000.00 of the true and full value of newly constructed residential dwellings as set out above, exclusive of land, are exempt from taxation for the first two (2) taxable years.
