MINUTES OF THE MEETING OF THE PEMBINA COUNTY WATER RESOURCE DISTRICT BOARD OF MANAGERS HELD IN THEIR OFFICE IN THE LAW ENFORCEMENT BUILDING, CAVALIER, NORTH DAKOTA.

Those present were Managers Richard Kendall, Randall Emanuelson, Charles Thacker, Donald Kemp, Ted Juhl and LuAnn Kemp, secretary. Attorney Fleming also present. Discussion on request by Don Kemp regarding the minutes- Dan Fischer will be contacted regarding the minutes from the Assessment meeting.

A motion was made by Charles Thacker, seconded by Randall Emanuelson, by vote unanimously carried to pay the following bills:

Attorney Fleming presented updates. Drain 81 – still waiting on responses from the Augustin and Heuchert attorneys regarding the easements. Drain 82 – Terry Lorenzen counteroffered on the drain 82 easement. A motion was made by Randall Emanuelson, seconded by Charles Thacker, by vote unanimously carried to accept Lorenzen's offer of \$14,000 due to the proximity to the house and loss of yard.

Jeff Stevenson met with the board regarding questions on several items. The O & M agreements from the construction of the dams was reviewed. Discussion on operation of Morrison Dam – the dam does not have any gate so there is no manual operation. Discussion on work by Vivatson on the former township road near Morrison Dam – email chain from ND SWC Dam Safety and Corps of Engineers provided. The board does not have jurisdiction in any water quality concerns. Discussion on the watershed planning efforts and local costs for Senator Young, Olson and Bourbanis dams.

Mike Ferrie – Houston Engineering and Jeff Duray – Triple D Construction met with the board regarding the Snagging and Clearing project in Cavalier city limits. Ice conditions are not favorable to completing this year. Discussion followed on extending the project to next year. A motion was made by Charles Thacker, seconded by Ted Juhl, by vote unanimously carried to extend all dates in the contract to the comparable date in 2022 due to unfavorable conditions of the ice.

Manager Kemp reported that a group of landowners from Drain 16 have met to consider options for a lateral. Discussion followed regarding the methods to bringing a drain to the a vote. The board could do the first resolution without a petition; however, the land to be assessed would still vote the project before establishment. Fleming also discussed the conflict of interest for the board members if carrying petitions, etc.
