Discussion on the Drain 47 crossing – currently an 18 inch is in place – would recommend a 24 inch – no further decision made.

Drain 13 – the advertisement for bid is published with bid openings scheduled for June 22, 2021.

Drain 80 – meeting with Walsh County is being scheduled for June 15, 2021 in the afternoon.

Keith Weston – Red River Retention – discussed options for radio ads. Board would prefer to move further with the Park River project before radio ad. Board would consider radio ad for the Tongue River Dam projects.

Curt Christenson and Mike Stellon met with the board regarding Drain 3. Discussion followed on replacing culverts in Highway 44 with two 36 inch lines by 60 feet and cleaning culvert to culvert from cement spillway back. Soft- bid project will be prepared for the project.

A motion was made by Charles Thacker, seconded by Ted Juhl by vote unanimously carried to approve hiring Dakota Helicopter for 2021 cattail spraying.

Attorney Fleming updated on projects – Drain 82 – easements need to be finalized with several landowners.

A meeting will be scheduled with Brian Prince regarding repair work needed on Drain 73.

Manager Juhl reported on the cleanout of Drain 39 in Section 14 – may need to clean from the south side only – waiting on guidance from the NRCS.
