SUMMER WEIGHT LIMITS FOR TRUCKS AND BUSES ON PEMBINA COUNTY HIGHWAYS.

WHEREAS, it is necessary that the Board of County Commissioners prescribe weight limits for Pembina County to protect asphalt surfaced highways,

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Pembina County that the following weight restrictions be imposed on all vehicles operating on County Highways:

#### State limits apply to the following Roads; No load shall exceed 105,500 lbs.

County Highway #1 State Hwy #32 to I-29

County Highway #2 from County Hwy #55 to State Hwy #5

County Highway #3 Cavalier County Line to I-29 to Bowesmont Spur

County Highway #4 Carlisle Road from US Hwy #81 to County Hwy #1

County Highway #7 Gardar

County Highway #9 Walhalla to County Hwy #12 at Leroy

County Highway #11 St Thomas to I-29

County Highway #12 from State Hwy #5 South to Walsh County Line

County Highway #44 Pittsburg south 4 miles to Hwy #66

County Highway #12 from State Hwy #5 North to County Hwy #55

County Highway #55 from Cavalier County line to I-29

County Highway #4 from Walsh County line to State Hwy #66

## <u>6 TONS PER AXLE WEIGHT RESTRICTIONS</u>

Load restrictions set at 6 tons per axle, with no vehicle to exceed 60,000 lbs. on the following County roads:

County Highway #6 (Concrete Spur)

PENALTY FOR VIOLATION OF ANY OF THE AFOREMENTIONED WEIGHT LIMITS SHALL BE MADE IN ACCORDANCE TO CHAPTER 39-12 NDCC.

BE IT FURTHER RESOLVED that trucks in excess of 1 ton shall be limited to a 40 mile an hour speed limit on County roads. Drivers are to use caution when bringing vehicles to a stop and when starting.

BE IT FURTHER RESOLVED that such weight restrictions shall be in force as of June 8th, 2020 and during the period that there are erected and maintained at each of any highway or portion thereof affected by such restriction, signs designating the provision of this resolution.

Said resolution proposed by <u>Hugh Ralston</u>, seconded by <u>Nick Rutherford</u> and upon a vote carried unanimously.
