Devon Johnson – Pembina County Highway met with the board. Johnson discussed the culvert replacement needed on Drain 77 that was completed during the bridge repair. A motion was made by Donald Kemp, seconded by Randall Emanuelson, by vote unanimously carried to approve the ND SWC permit for Drain 64 reconstruction.

A motion was made by Randall Emanuelson, seconded by Donald Kemp, by vote unanimously carried to approve the contract with Kendall Construction for Drain 66 Phase 4.

The board reviewed the engineering report of Houston Engineering on the Mahar/Vivatson, etc versus Pembina County DOT complaint. A motion was made by Donald Kemp, seconded by Randall Emanuelson, by vote unanimously carried to dismiss the complaint as the elevation of the bridge does not obstruct the flow.
