Drain 81 punch list has been provided to the contractor who plans to start this week, some seeding issues; area on the drain was sprayed by landowner and may need to be reseeded, same area has some damage to the turf reinforcement mat, repairs in this area will be tracked by parcel to bill back to the landowner
 - d. Drain 78 discussion on the possible of also applying for NDDWR funding; discussion on the NRCS easements in the area
- 5. Drain 64 discussion on needed repairs to the culverts and channel grades; Houston will work with ND DOT regarding permitting the crossings
- 6. Drain 5 discussion on capacity west of interstate; review of the original as-built design confirms very small capacities; meeting will landowners will be scheduled for after harvest
