Duray reported that the Drain 7 outlet is complete. The bend was flatter than initially planned for, however, he was still able to raise outlet pipe about 2.5 feet and maintain 6 inches of drop in the pipe. Manager Juhl reported the project looked good.

Duray has installed the Drain 38 trap for the Myrdal culvert.

A motion was made by William Gunderson, seconded by Ted Juhl, by vote unanimously carried to approve the contract for the Renwick Dam Safety Repairs as presented. Pre-construction meeting is set for October 14^{th} @ 10:00 am.

The board opened the Drain 78 Outlet bids at the time and place stated in the advertisement. Bids received were as follows:

Tunheim Construction \$288,656.00 Gladen Construction \$317,778.35 Triple D Construction and Leasing \$359,727.50

Mike Ferrie – Houston Engineering reported by telephone that the bids were correct. A motion was made by William Gunderson, seconded by Ted Juhl, by vote unanimously carried to accept the bids for the Drain 78 Outlet repair.

Ferrie discussed the site inspection of Wieler Dam. The cover of the monitoring well had fallen in due to rusted hinges but has since been retrieved and is being repaired. The foundation drain was plugged and did begin draining when the outlet was uncovered by hand. The outlet pipe needs cleaning. Discussion followed on process to clean the drain and timing. Kendall Gemmil will be requested to monitor the level of the water in the monitoring well and report it to Ferrie. Current plan is to scheduling jetting for early summer 2026.

Ferrie reported that favorable reviews of Tunheim Construction from others at Houston Engineering. A motion was made by Ted Juhl, seconded by Richard Kendall, by vote unanimously carried to award the Drain 78 Outlet project to Tunheim Construction.

Ferrie provided the hydraulics report for the Drain 67C culvert in response to T. Kennelly's concerns about sizing. Compaction testing has been doing well and project is nearing completion.

A motion was made by William Gunderson, seconded by Ted Juhl, by vote unanimously carried to approve the First Half 2025 General and Drain Fund Financials and the Pledge of Assets from United Valley Bank.

The board discussed the levels of water at the dams. A motion was made by William Gunderson, seconded by Richard Kendall, by vote unanimously carried to open Renwick Dam gate for drawdown of 18 inches by October 14, 2025 to allow for storage during construction.

Manager Juhl reported on Helm Construction starting on the Drain 78 culvert replacement.

Manager Gunderson inquired as to the status of the railroad pilings left in Drain 67 by St. Thomas.
