Sean Morton has already been contacted and will be reviewing the area when he is here to spray and will be providing the spray maps to the office.

Manager Emanuelson reported on a damaged trap on Drain 13. A motion was made by Randall Emanuelson, seconded by Ted Juhl, by vote unanimously carried to approve the purchase of the trap if needed and allow landowner to install if agreeable.

Zach Hermann and Michael Ferrie – Houston Engineering were present for updates.

- Shannon Heck present to discuss proposed mitigation options downstream of Bourbanis Dam. Currently, a small berm is being proposed to prevent flow from entering his yard/electric box/well. Discussion on possible funding mechanisms and permit requirements. Manager Gunderson discussed possible options to move the electric and connect the property to rural water instead.
- Christi Fischer is requesting dams to be drawn down so that Renwick can be closed for inspection in late October.
- Drain 4 the rip rap apron repair in the ND DOT was discussed; Houston will help to provide basic description of the work to solicit quotes; Manager Gunderson will review the site with Houston after the meeting
- Drain 67A discussion on the needed berm repair; Houston will review the elevations up and downstream of the berm to propose a repair
- Drain 81 construction is complete and punch list is nearly done will be working on final pay estimate; discussion on warranty and withholding of retainage FEMA deadline is in January 2025 for final pay
- Drain 66-1 contract was returned and intends to start work October 1; trap is available for pickup from Helm and culvert is available from Pembina County DOT
- Drain 78 working on mitigation proposals
- Drain 64 discussion on the need for DOT approach permits which might be a problem as normally would not allow three approaches that close together
- Drain 5 Extension discussion on the small capacity of the current design and options to increase the size west of interstate meeting with landowners this fall
