Motion made by Blaine Papenfuss and seconded by Jim Benjaminson to approve the August 20, 2024 meeting minutes as presented. All voting in favor; motion carried.

Motion made by Laverne Doyle and seconded by Blaine Papenfuss to approve the August 27, 2024 special meeting minutes as presented. All voting in favor; motion carried.

Angelle French with the Red River Regional Council and Haylee Viger with the North Dakota Department of Agriculture gave a presentation on a regional livestock planning grant. They are requesting a signed resolution for Pembina County to enter into an agreement with the Red River Regional Council to apply for a Regional

Revel Sapa asked the council for approval for outside work for approximately one to two nights per week. Motion by Darin Otto and seconded by Jim Benjaminson to approve Revel Sapa for an outside job. All voting in favor, motion carried.

Lisa Keney, Tax Director gave an update to the commission on the Sidwell Contract. It was originally approved with 40 extra hours but the amount was not included in the original total approved. There was an additional \$5,200.00 for those extra hours.

Jeff Daley from KLJ gave an update on the collapsed box culvert on County 4 and Junction 1. Gowan has been removing material. The structure will be taken out today, 9-3-24 and a geotechnical engineer will be on site on 9-5-24 to do soil borings to see if they can figure out what happened. The NDDOT stated the county may have to pay for the temporary crossing upfront until the cause was for the collapse is determined. Mr. Daley stated he would keep the county updated as he gathers information.
